Project Background

- 2008: County Board of Supervisors approved the Infill Program and Principles
- 2008 2022: Further implementation lagged due to recession, shift in project priorities, and Covid-19 pandemic
- 2022: County received State Local Early Action Planning (LEAP) Grant to fund an update to the 2008 Infill Program

What is "Infill"?

- Construction or redevelopment of properties in existing urbanized areas including:
 - Underused parking lots
 - Vacant buildings or properties
- Alternative to expanding the development footprint (e.g., "sprawl")







What are some potential benefits of "Infill"?



Locate housing near jobs, transit, and services



Promote active transportation



Reduce GHG emissions and improve air quality



Support a mix of housing options for all income levels



Revitalize the economy




Encourage communities with a sense of place



Reduce costs to build and maintain infrastructure








Breakout Room – **Map A**





